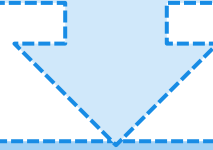

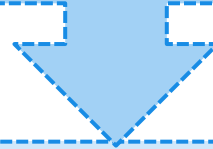

Detailed Candidates' Eligibility criteria (PMIS Pilot Round III)

Youth aged between 18 and 25, as on the date of application submission, who are not employed full time



Candidates who have passed High School, Higher Secondary School, possess a certificate from an ITI, hold a diploma from a Polytechnic Institute, or are undergraduates with degrees such as BA, B.Sc., B.Com, BCA, BBA, B.Pharmaceuticals, B.E./B.Tech etc. or postgraduates with degrees such as MA, M.Sc., M.Com, MCA, M.Tech etc. are eligible to apply



Candidates **must not be engaged in full-time education**. However, candidates **enrolled in online or distance learning programs or candidates enrolled in the final year of full-time graduation or post-graduation** are eligible to apply.

Detailed Candidates' Non-Eligibility criteria (PMIS Pilot Round III)

Must not be graduates/postgraduates from IITs, IIMs, National Law Universities, IISER, NIDs, IIITs and IISc, and must not hold professional qualifications such as CA, CMA, CS, MBBS, BDS, MBA, or PhD



Those **undergoing** any skill, apprenticeship, internship or training program under Central Government or State Government schemes are not eligible



Those who have **completed** apprenticeship, training under (NATS) or (NAPS) at any point are not eligible



Income of any family member must not exceed **₹12 lakh** in the preceding financial year as on the date of application submission.



No family member should be a permanent/regular government employee (family includes self, spouse and parents).

Companies Eligibility Criteria (PMIS Round III)

Category A

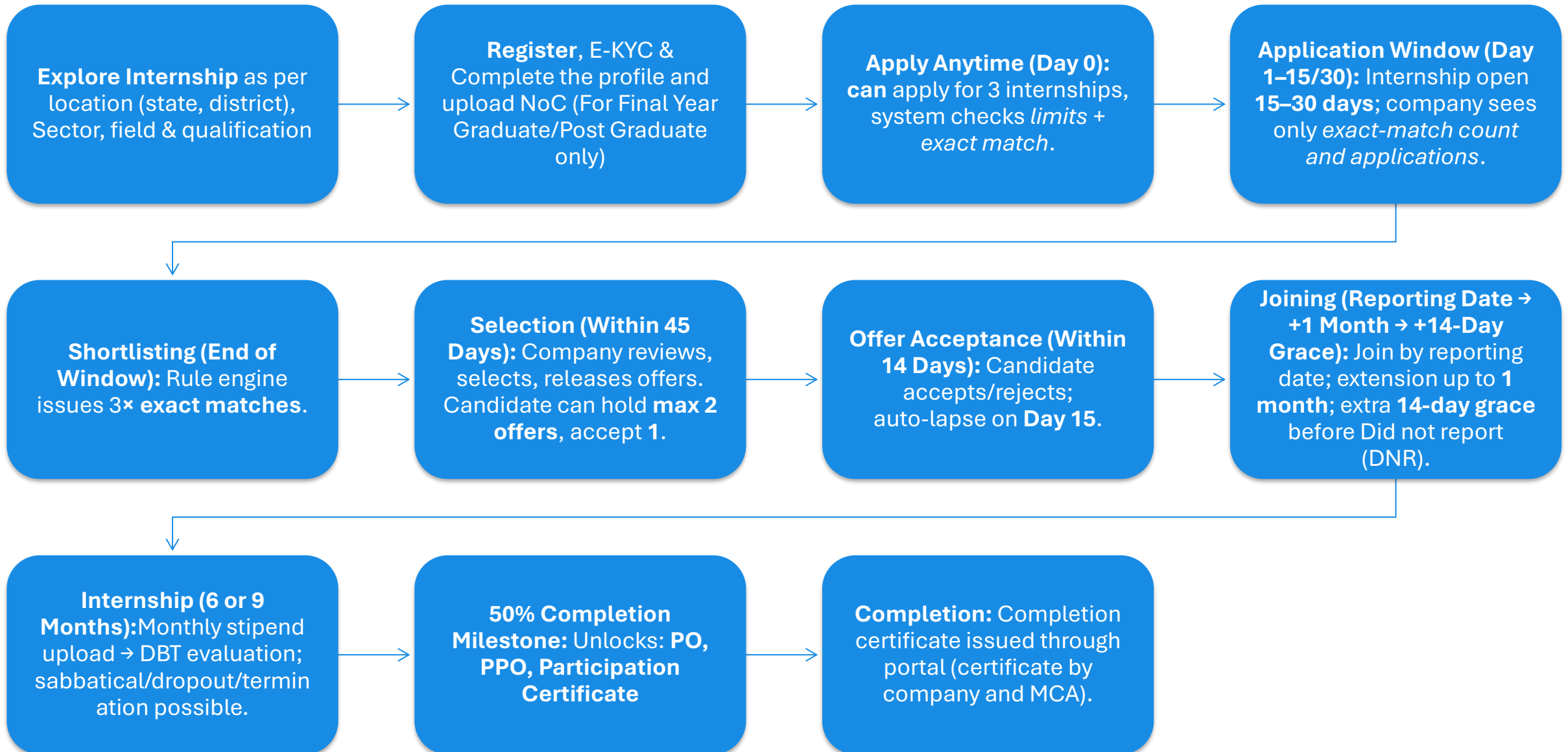
1. 353 Companies participated in the previous rounds and Top 2,000 companies as per average CSR during the last three financial years are eligible to participate and
2. Companies with CSR Expenditure in Each of the Last 3 Financial Years (FY 2024 25, FY 2023 24, and FY 2022 23), are eligible (subject to MCA approval) if they meet any one of these sub criteria:
 - Turnover $\geq$ 1000 crore, or
 - Net worth $\geq$ 500 crore, or
3. Companies from under-represented sector
 - Internship opportunities must not exceed 15% of the company's total workforce.
 - Minimum number of Internships: 50

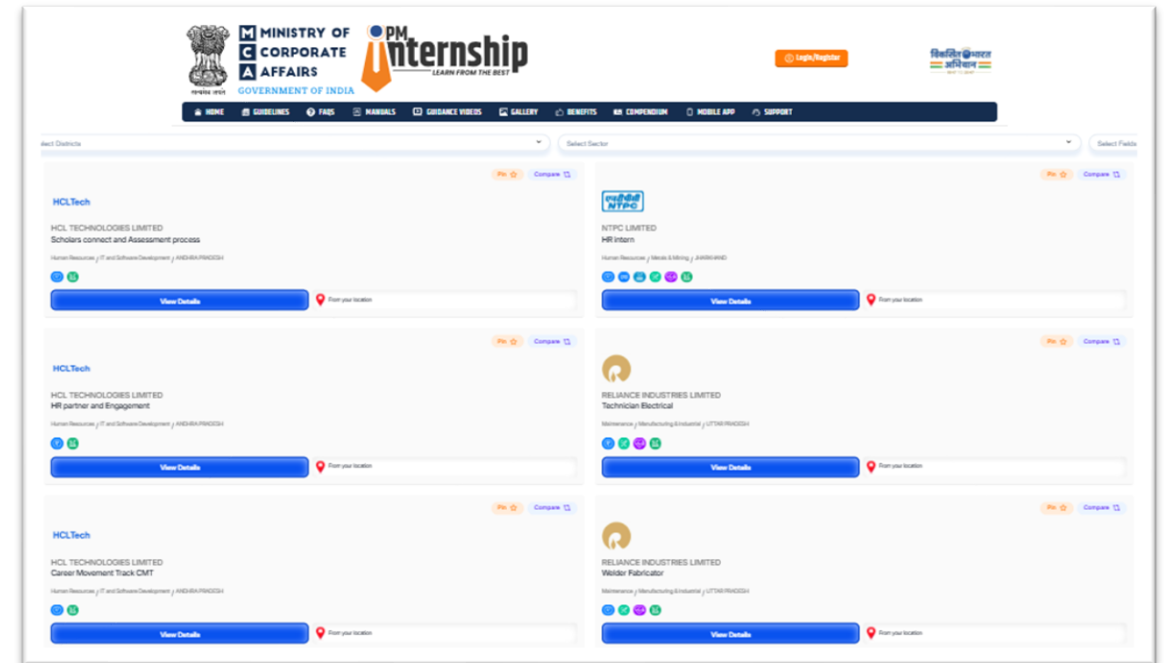
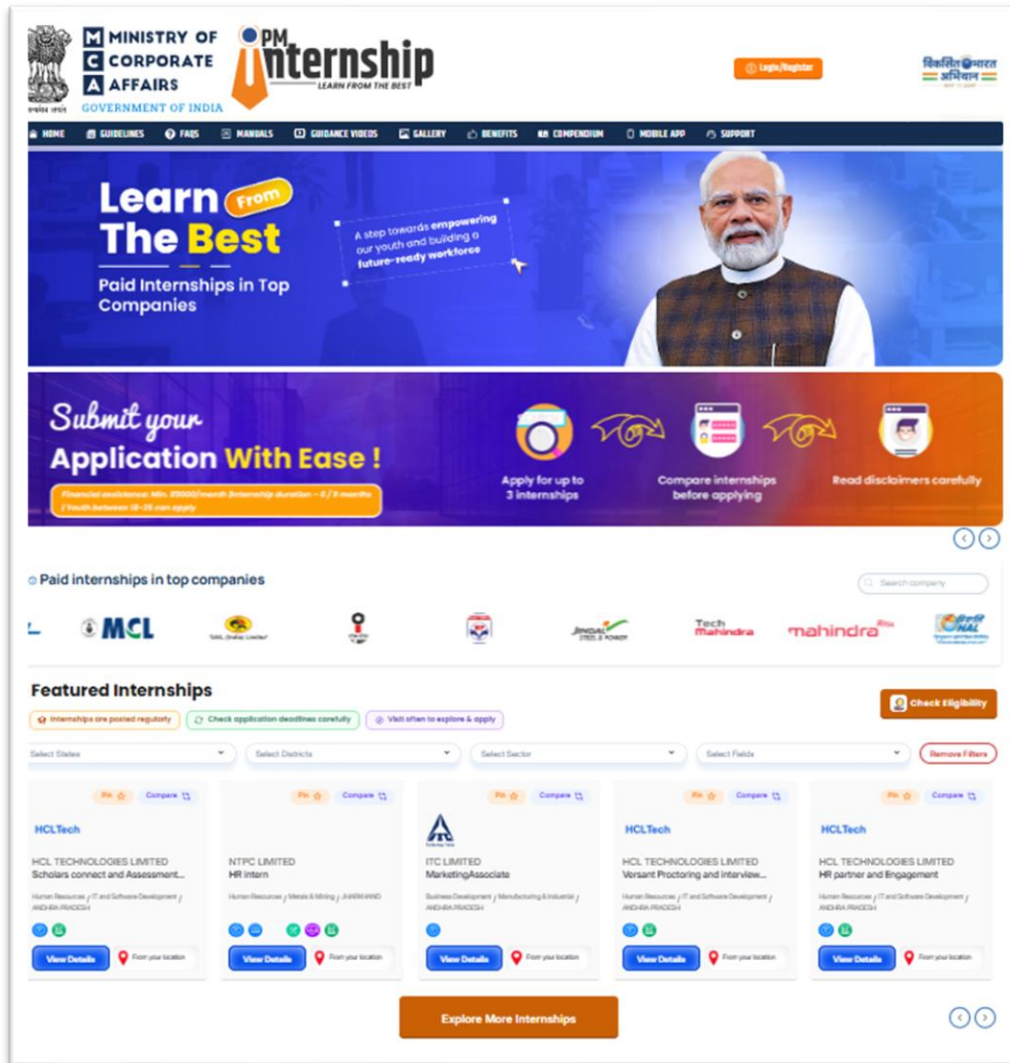
Companies from the following list are eligible:

1. Professional Associations/ Institutions (ICAI, ICSI, ICMAI)
2. Selected MSMEs through Sectoral Associations
3. Global Capability Centres (GCCs)
4. Special Economic Zones (SEZs)
5. Statutory authorities like AAI, Shipping Corporation etc.
6. State-nominated Companies (up to 20 companies)

A CAMP is a short, one-day (sometimes up to two days) event where students and companies come together at one place. Students can apply for internships and get selected on the same day.



How CAMP Works



1. Interaction

Students interact directly with company representatives.



2. Assessment

Companies assess students on the spot.



3. Application

Students apply for internships during the event.



4. Evaluation & Selection

The entire process—application, evaluation, and selection—happens at the same time and place.



5. Duration

Depending on the number of candidates, the activity may extend to 1–2 days.

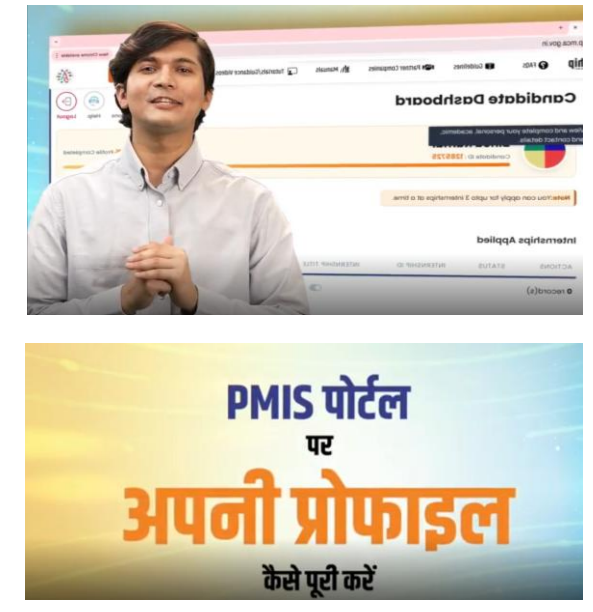
